PEM PAL LUBLJANA WORKSHOP Survey

On April 18-19, and 22, 2011 PEM PAL TCOP Workshop took place in Ljubljana, Slovenia.

After the event the on-line survey in three languages were created. The aim of the survey was to receive event feedback and to collect information concerning PEM PAL TCoP.

The survey started to collect responses in April 29 and finished in May 13, 2011. Invitations to take part in the survey were sent to all participants of the workshop.

30 persons started to response to the survey. 23 responses were fully completed. In this report we analyze all 30 valid responses. For further calculation we take this quantity as 100%.

The questionnaire comprises four parts: one concerning PEM PAL TCoP, and three other: Event Delivery, Event Administration and Overall Impression. There are total 21 questions in it.

PEM PAL TCop

Q1. How do you rate your participation in PEM PAL TCoP?

There are 30 answers (100%) to this question. According to the figures below people are well informed and they are interested in being an active member of PEM PAL TCoP.

Not positive responses are highlighted.

Q2. With which PEM PAL country have you most contacts between TCOP events?

22 respondents (79.3%) gave answers to this question.

Croatia was mentioned 8 times.

Macedonia was mentioned 7 times.

Moldova and Albania were mentioned 4 times.


Kyrgyz Republic and **Turkey** were mentioned 3 times.


Azerbaijan, Russia, Serbia, Slovenia, Georgia and Tajikistan were mentioned 2 times.

CIS countries, Kosovo, Romania, Bulgaria, Kazakhstan, and Ukraine were mentioned once.

Q3. Have you used the experiences of your fellow TCoP members or other learning in the TCoP to design, recommend or implement reforms in your area of practice in 2009 and/or 2010?

"Yes" said 7 respondents (26.9%); "No, but I am likely to in future" – 19 respondents. (73.1%) And nobody chose "No and I am unlikely to in future". Total answered question – 26 (86.7%)





Q4. Please give an example of how your participation in TCoP has influenced your practice.

There were left 21 valid comments. Here are some quotations from informative comments:

"On the Russian model the Law on Treasury have been changed in the part connected with cash servicing of public sector entities. $(1)^1$

"It does not have much influence because it is first necessary to convince our environment about the importance of public finance reform" (4)

"As a result of the meeting in Dushanbe the agreement on technical help was concluded with IMF. Manager from IMF side – John Zohrab, and other involved consultants. As a result of the meeting in Zagreb Worldbank granted us via trust education company SAFE.. " (15)


"Considering our obligations at work, the workshop duration was fine." (3)

There were left 10 comments. Here are some quotations from informative comments:

17. What did you like best about the workshop?

20 comments were left.

Participants liked best:

- 1) 'Exchange of experience' mentioned about 7 times. For example: "Sharing experience with experts and countries more developed in accounting reform" (8)
- 2) 'Presentations' mentioned about 6 times, in particularly "Presentation of Macedonia and Albania" was mentioned 4 times.
- 3) 'Work of international experts' –mentioned about 8times. For example: "That such experts as Michel Perry, professor doctor F.D.J. van Shake gave us clear answer and recommendations." (17)

And more other things.

18. Which elements of the workshop you did not like?

16 comments were left. Half of them – 8 answers – are comments: "I liked everything". And there are also 2 comments – "I have no objections".

It means that we have only 6 comments about elements whish were not like by participants.

Workshop participants did not like different elements of the event. For example: "Answers to some questions provided by experts, although I think that they sometimes they could not adjust their theoretical knowledge and practical experience to the questions" (10)

[&]quot;Right choice of topics and presenters, with a desire for more active involvement of Serbia" (3)

[&]quot;Generally all questions were chosen very well and the workshop met my expectations." (1)

[&]quot;Everything was in accordance with the submitted Agenda" (5)


19. Suggestions to improve the content, approach and other aspects of the workshop:

12 comments were left. Half of them -6 – are comments "I have no suggestions".

Example of a comment with suggestion: "More practical cases and focus on specific subtopics" (7)

20. Do you plan to brief your colleagues on this event?

24 (80%) responses were given. 95.8% of them are positive and only 4.2 % - negative.



There were left 15 comments. And most of them are positive:

"We are preparing a presentation for the staff members of Tajikistan Ministry of Finance." (1)

"I took the materials in Serbian and distributed them to my colleagues in the Treasury Administration and to the Standing Conference of Towns and Municipalities." (8)

There were no negative comments

21. Would it be useful for you or your colleagues to attend the future TCoP meetings?

24 persons (80%) responded to this question and 100% of the answers are positive.

14 valid comments were given. All of them ate positive and enthusiastic.

For example: "Of course, for me and my colleagues it would be very useful to participate in the future TCOP events, because right now our country reforms accounting in public sector and develops national accounting standards compliant with IPSAS". (2)
