PEM PAL IACOP SV to Moldova Feedback Survey

On March 16-19, 2015, PEMPAL Internal Audit COP organized a study visit to Moldova After the event, the on-line survey in two languages was created. The aim of the survey was to receive event feedback.

The questionnaire comprises five parts: About the Respondent, Event Delivery, Event Administration, Overall Impression, and Recommendations for the Future. There are total 23 questions in it.


This question was seen only by those respondents who chose "No" in the previous question. 4 respondents answered this question.
