PEM PAL BCOP WG MEETING IN MOSCOW FEEDBACK SURVEY

On May 25-26, 2014 PEMPAL BCOP WG meeting took place in Moscow, Russia, before the CROSS-COPs Plenary Meeting.

After the event, the on-line survey in three languages was created. The aim of the survey was to receive event feedback.

The survey started to collect responses on June, 5 and finished on June 26, 2014.

Invitations to take part in the survey were sent to all participants of the event.

20 responses were received—19 from those who attended Cross-Cops Plenary meeting and 1 from those who was only on BCOP WG meeting.. In this report, we analyze all 20 responses. For further calculation, we take this quantity as 100%.

All these responses will be included in the general Feedback Event Database. All responses are not identified by source and sent on a confidential basis to Nina Duduchava of the World Bank who prepares this report.


The questionnaire comprises five parts: About the Respondent, Event Delivery, Event Administration, Overall Impression, and Recommendations for the Future. There are total 23 questions.

ABOUT THE RESPONDENT

Q1 You are..

20 (100%) respondents gave answers.

Q3. How many PEMPAL events have you attended before?


This question was seen only by those respondents who chose "No" in the previous question. 14 respondents answered this question.

2 comments were left: (Here and after pieces of critical feedback are underlined.) Practically all of them are very positive:

- 1. Overall, the event was planned and carried out in a high level, it is desirable that the discussions were active.
- 3. From my standpoint (I am a civil servant, but working on the issues relevant to self government operations), I believe that lectures are missing a link between state and local level. Lectures are mainly concentrated on state level operations' analysis, while local self government is mentioned only slightly. When discussing decentralization issues and affairs, it is difficult to compare it with other states experiences and practices, because every state is very self specific in these matters. For example, I have noticed that in some states local self government budgets are consolidated within the state budget, which is not the case in Croatia (in addition to other specific characteristics). We have state budget and 576 local self government budgets, for whose execution the heads of those units are responsible. I would dare to say that we function on the basis of one saying: "Think globally, act locally!". All that makes sense because all is based on individual tax payer to whom the local self government level is much closer than the state one. At the local level one can act easier, faster and more efficiently. For that reason I am suggesting that in the future you prepare a lecture covering in more depth the issue of importance of local self governments and how to improve them.

- 3 informative comments were left about outcomes of BCOP WG meeting.
 - 1. Employment and wages issues are very important for every country, and therefore very useful to exchange experiences
 - 2. In our country, these questions are relevant, I would like to raise the level of knowledge in all 3 of the above issues. For me it is also important to establish contacts with colleagues from other countries in the following areas: control of payroll and employment fund, laws on wages, automated human resources management system.
 - 3. I believe that we have made a significant step forward, but there is still room for further improvements. Those states that do not have established legal framework in this area (local self government level), have gained information on how to do it, while those with the set legal framework can consider on how to improve it, because there are always better options to reflect on.

PART 2 EVENT ADMINISTRATION

Answered question -20 (100%). Most of the ratings are very high.

There were left 5 very positive comments. Most of commenters (4) responded that quality of administration and organization was great. For example: "Everything was provided in timely manner and in good spirit!", "Staff was extremely kind and always available for all additional requests. I would like to give special praises and tribute to all ladies and gentlemen colleagues from the CEF."

Q11. Did you receive agenda and event information in sufficient time before the event for them to be useful?

20 (100%) answers were given. And 100% responses were "Yes".

Q12. Did you receive practical information (about the accommodation and other facilities, etc.) prior to the event?

19 (95%) answers were given. And 94.7% of respondents (18) replied "Yes". 1 person (5.2%) did not receive practical information prior to the event.

Q16. What did you like most about the event?

14 comments were left. All of them are valid. Participants like different aspects of the event:

Organization and **work of resource team** were mentioned in 5 comments For example: "Everything was very well organized."

Participants like to **share experience with colleagues and experts**: "Realise that the colleagues from other countries are engaged in the same issues as you, listen to the experts of different areas, and most importantly, look at what you do in your work from a different perspective"

Experts' and colleagues presentations were mentioned 6 times. For example: "Every lecture in its own manner. Optimally addressed. Looking from the human stand point, one cannot expect more."

Active participation: "Active participation of PEMPAL members."

Q17. What did you not like most about the event?

11 comments were left. 5 of them are comments like "I liked everything" or "Nothing" It means that there are 6 comments about elements which were not liked by participants.

- 1. I can not single out anything as they are also some disadvantages and advantages (intensity lectures).
- 2. Not enough social events

- 3. Having in mind that I hold a position where I can provide my suggestions and recommendations via presenting law and by-law amendments as well as in other manners, I can contribute to the improvement of current state of affairs in my country.
- 4. In planning BCOP events next year. In delivery of technical assistance to countries of the region.

RECOMMENDATIONS FOR THE FUTURE

23. Do you have any suggestions to improve the content, approach and other aspects of such events in future?

9 comments were left and 2 of them consist suggestions.

Here they are:

- 1. Consider possibility to discuss issues of interest in detail with experts.
- 2. I have already presented suggestions in my previous comments. Also, try somehow to give more space to local self government issues.

Q24. Are there any other products, research or services that PEMPAL could provide that would be useful for your work?

9 comments were left. And 5 of them are informative.

Here they are:

- 1. I think that this question should be discussed in leadership groups
- 2. Which ratio in wages have government employee? Who receives more in other countries a policeman or a doctor, what determines teacher's salaries, how payroll controls in the countries with limited financial resources, what is the role of the Ministry of Finance in wage policy for public sector employees?
- 3.to investigate what decentralization issue stands for in different countries. What state level operations are delegated to local level? How, and in which manner are those operations financed? Who is financing local self government wage bill spending what is the source is it intergovernmental or local government? Sources of financing for teachers/professors? Medical staff doctors, nurses?
- 4. Participation in events such as the annual meetings of senior officials, as well as training seminars in countries with high level of transparency (OBI)
- 5. I would be to my job interest to attend a study visit, in a country having in place strong internal control system.
