# 1. Program for 2007

# 1.1. Activities which can be performed by the group with the support of PEM-PAL and the World Bank:

- 1.1.1 (**Step One**) Development of a questionnaire to study the training needs regarding managerial accountability, controls, inspection, and audit;
- 1.1.2 (**Step Two**) Preparation of an analysis of the results of the training needs assessment:
- 1.1.3 (**Step Three**) Elaboration of a training programme;
- 1.1.4 (**Step Four**) Development of 3 level training modules designed to meet the training needs:
  - **Level 1:** Basic methodological documents in the area of internal audit (Standards, Charter, Code of Ethics, etc);
  - **Level 2:** Methodological documents in the area of internal audit with higher specific (risk assessment, planning, etc);
  - **Level 3:** Training courses intended to facilitate the preparation for the certification examinations;

### **Key conditions:**

PEM-PAL and the World Bank shall support the group by the implementation of the steps described above by translation, distribution and analyzing of the results from the training needs assessment and the training programmes of the countries, as well as by the development of the training programme and modules.
